Minimum Advertised Price (MAP) Policy.

Policy Effective Date: May 15, 2024.

With many years of presence in the market, CINSA USA, Inc. (the Company), under its authorized brands GRANITE WARE® and CINSA®, has been a companion to generations of American and Mexican families. Firmly grounded in heritage and tradition, we are dedicated to crafting the finest products that enhance your recipes with nutrients and flavors, contributing to the well-being of consumers. The diversity of our product range is the result of our commitment to excellence. With each piece crafted by our hands, we bear the responsibility for the well-being of those who place their trust in us.

This MAP Policy is designed to protect the value of our products and the investments made by CINSA for the brands GRANITE WARE® and CINSA® mentioned in this document. This MAP Policy applies to all listed GRANITE WARE and CINSA products.

In order to preserve its reputation for providing customers with high value products the Company is unilaterally instituting a policy of minimum advertised price standards. This Minimum Advertised Pricing Policy ("MAP Policy"), will apply to resellers, distributors, dealers and retailers, including catalogs and internet retailers (collectively, "Resellers"), who resell products to end users located in the United States of America.

The Company greatly values the efforts of all Resellers to distribute products and support our customers. This MAP Policy is adopted for the benefit of all Resellers and will be uniformly enforced.

The importance of comply with this MAP to cover the products under the brands GRANITE WARE® and CINSA are:

- ✓ to help prevent price wars which can be detrimental to retailers and the Company.
- ✓ incentivizes retailers to compete on value and service.
- ✓ it helps to ensure that aggressive discounting and price-cutting will not diminish the brand's reputation for quality.

This MAP Policy will not affect the resale prices that Resellers may choose to charge or sell the products covered by this document. The Company or any of its employees and executives, may not determine the minimum selling prices for products subject to this policy. This MAP Policy does not establish maximum advertised prices.

This MAP Policy shall work under the following guidelines:

1. Products covered by this Policy:

The products covered by this document as of the effective date above, and the corresponding Minimum Advertised Price ("MAP"), are established on the "Minimum Advertised Price List" ("Covered Products") attached hereto. From time to time the Company may provide updates or amendments to the Covered Products at its sole discretion. A breach and/or violation of this MAP Policy occurs when a Reseller and one of their Resellers advertises the Covered Products below this MAP.

2. Resale price at reseller's discretion:

The MAP Policy only applies to advertised prices of the Covered Products, and not the prices at which Covered Products are actually sold. The Resellers is free to resell the Covered Products at any price of its choice. The

MAP Policy is not intend to affect the resale prices. Resellers may choose to charge or to require any Reseller to actually sell the Covered Products at the listed Minimum Advertised Price.

Each Reseller is free to determine independently the price(s) at which it Resells the Covered Products. The Company does not seek any person's agreement on minimum selling prices and their representatives, executives or employees are not authorized to accept any agreement on the minimum selling price.

This MAP Policy applies only to advertised prices and does not apply to the price at products are actually sold or offered for sale to an individual consumer within Reseller's retail location or over the telephone. Resellers remain free to sell these products at any prices they choose under these circumstances.

3. MAP Applications:

- The MAP Policy applies to the internet and internet-related electronic media: emails and its responses
 even automated email responses, newsletters emails, emails solicitations, social media, audio, video,
 Reseller websites, third-party websites and marketplaces.
- Automated email responses to customer pricing requests are also considered advertising.
- Any price information relating to the Covered Products on an internet website which can be accessed
 directly through any hypertext link, search, App(s) or by any other method which uses the hypertext
 transfer protocol (HTTP) is considered to be advertising for this Policy.
- Any prices shown on a Reseller's website, marketplaces or any ecommerce site are considered
 advertised prices and subject to this Policy until the consumer is committed to the purchase of the
 covered product.
- Published prices on any Internet site are considered an "advertised price" and must adhere to this MAP
 Policy. Once the pricing is associated with the intent to purchase (added to a secure, not public shopping
 cart or order), the price becomes the selling price and is not bound by this MAP Policy. Discounts applied
 at the checkout to the entire order based on a customer's purchasing history with the Reseller, such as
 discounts for "frequent shoppers", do not violate this MAP Policy.
- The MAP Policy is not applicable to any in-store advertising that is displayed only in the store and distributed to any consumer(s) other than while the consumer is visiting a physical store. The MAP Policy does not apply to shelf talkers, price tags or window displays. However, advertising any of the Covered Products below MAP on exterior store banners is a violation of the MAP Policy.
- This MAP Policy also applies to traditional media such as coupons, mailers, inserts, flyers, newspapers, posters, magazines, catalogs, mail order catalogs, TV and radio.

4. Enforcement:

Resellers advertises prices below those required by this MAP Policy, sanctions will be unilaterally imposed by the Company, including but not limited to one or more of the following actions:

- ✓ Could notify the of the non-compliant advertisement with a reminder of the MAP Policy on Covered Products;
- ✓ Loss of any discounts;
- ✓ Termination of buying privileges for the Covered Products.

- Cancel any pending orders, and suspend the right to sell the Covered Product in question for a period of time (e.g., thirty (30), forty-five (45) or ninety (90) days) depending on the breadth and severity of the MAP Policy violation, commencing from the date of notice from the Company;
- ✓ Cancel any pending orders, and suspend the dealer's right to sell the entire the Company product portfolio for a period of not less than one (1) year, commencing from the date of notice; and/or
- ✓ Terminate the Reseller agreements or other relevant agreement.

The Company will make all decisions concerning compliance with and enforcement of this MAP Policy unilaterally. This MAP Policy is a unilateral declaration and does not reflect or constitute an agreement between the Company and any Reseller, or any other person or entity, and by issuing this policy is not seeking any such agreement.

Intentional and/or repeated failure to abide by this MAP Policy will result in sanctions unilaterally imposed the Company. The Company does not intend to do business with Resellers who degrade the Company image and its products. The Company need not provide prior notice or issue warning before taking any action under this MAP Policy.

The Company reserves the right to determine whether a violation of the MAP Policy has taken place, and it will do so in its sole and absolute discretion and independent judgment.

5. Procedure:

This MAP Policy is solely within the Company discretion and authority acting through the duly authorized managers. No employee or sales representative of the Company has any authority to discuss, modify or grant exceptions to this MAP Policy. Any representation or action by any employee, sales representative or persons not specifically authorized to discuss, modify or grant exceptions to this MAP Policy under this paragraph is unauthorized and invalid. All questions about this MAP Policy should be in writing and directed via U.S. Mail to MAP Policy Administrator located at 1723 N Loop 1604 E Ste 210 San Antonio TX, 78232 — email: customerservice@cinsausa.com; who will respond only in writing. No oral communications about this MAP Policy are authorized. The MAP Policy Administrator shall be solely responsible for determining whether a violation of the policy has occurred, communicating decisions to Resellers regarding the policy and receiving any communications regarding sanctions imposed under this MAP Policy. Any action taken by the Company under this MAP Policy shall be without liability to the Company.

6. MAP Amendments:

The Company reserves the right to modify, suspend, or cancel the MAP Policy. The Company will provide notice of any such modifications, suspension or cancellations on their websites.
